### Procedure

# Revision #1 - May 6, 2020

## Steps:

- 1. Any modification that altars the exterior appearance of your home, paint color, the addition of any new landscaping (except annual flowers to existing or previously approved beds), new hardscaping (such as patios, paver bricks, decks or the addition of any concrete or stones) or any structural additions require a Villas of Northridge Modification Request Form to be submitted.
- 2. The form is found on the In Rhodes (The current Property Mgt. Company) web site located at InRhodes.com. Once on the home page, go to the menu and click on "Forms" and then select "Modification Requests". Scroll down till you come to the name Villas of Northridge and click there.
- 3. Print out the form and fill it out completely. Be sure to read fully the requirements located in the body of the form.
- 4. Please include all necessary drawings, sketches, pictures, and layouts needed to substantiate your request. If you have a contractor, they can help you with creating these documents.
- 5. Send the complete package to In Rhodes Management at:

- 6. In Rhodes will send the package to the BOD's Modification Lead and the remaining BODs.
- 7. The BOD's Modification Lead will schedule a site visit to review the request in detail at his and the homeowners' earliest convenience.
- 8. Following the site visit, The BOD's Modification Lead will review the information with the Board and a decision will be made to approve or disapprove.

9. The BOD's Modification Lead will notify In Rhodes of our decision and In Rhodes will in turn notify the homeowner.

Note:

- 1. Please note that if you apply for a permit at the Township, you will need an approved modification form from the HOA.
- 2. You cannot proceed with installation, painting, or construction until you have both the approved modification form and permit (if needed).
- 3. If you start before approval and any amendments, changes must be made, the cost will be the homeowner's responsibility.
- 4. If partway through installation/construction changes need to be made, that part of the project must cease, and revisions must be documented on the Modification Form and approved in writing.
